

**MINUTES OF A MEETING OF SNITTERFIELD PARISH COUNCIL HELD IN THE VILLAGE HALL ON
MONDAY 10 DECEMBER 2018, COMMENCING AT 7.30 PM**

1. Public Participation

None

2. Apologies

Apologies for absence were received on behalf of Councillor Mrs S Main and District Councillor P Richards.

3. Declarations of Interest

There were no Declarations of Interest.

4. To approve the Minutes of the meeting held on 12 November 2018

The Minutes of the Meeting held on 12 November 2018, having been previously circulated, were agreed and signed by the Chairman.

5. Resignation of a Parish Councillor

The Chairman reported that due to personal circumstances Mrs C Pearson had resigned from the Parish Council. The Chairman raised a vote of thanks to Mrs Pearson for her hard work and support to the Parish Council and all members expressed their sincere thanks to Mrs Pearson.

6. Report from County Councillor – Councillor Mrs A Parry

Community Grants

Councillor Mrs A Parry reported that Snitterfield Village Hall had received the largest share of the Community Grant Fund having been granted £750.00 towards the refurbishment works.

The next County Council meeting was to take place on Thursday 13 December 2018.

7. Matters Arising

a) Hurdlers Lane

Councillor P Cox reported that there were still a number of issues yet to be addressed at many of the homes on Hurdlers Lane. The gas pipe had still not been laid, and the gas connection was not expected to be completed before the end of January 2019. The Chairman was to meet with Douglas Doherty to discuss the issues still outstanding.

It was suggested that the Chairman and Councillor P Cox make the situation known to both the local press and Nadhim Zahawi MP and members agreed that this may assist in resolving the issues.

b) Play Areas

Councillor P Smith reported that he had obtained a quotation for the replacement of the balance beam and new fixings at a cost of £392.87 plus VAT and it was agreed that the work was necessary for safety reasons.

It was agreed that any painting of play area items should be left until the Spring when the weather improved.

Councillor P Smith confirmed that following his attendance of a course arranged by WALC, monthly inspections of the play areas would be carried out.

c) Playing Field Working Group (PFWG)

Councillor Kimberley reported that the PFWG had made a recommendation to the Parish Council for the "Snitterfield Playing Field" Charity to open its own bank account. It was considered that this would assist in any future grant applications for funding, as independent bank accounts were often one of the criteria for successful funding applications.

It was agreed unanimously that the "Snitterfield Playing Field" charity should open its own bank account.

The next meeting of the PFWG was to take place on Tuesday 11 December 2018.

Councillor S Main was to join the PFWG as a Parish Council Representative.

There was to be a Public Consultation at the Village Hall on Saturday 2 February 2019 to generate potential ideas and suggestions for the future of the playing field.

d) Website

The Clerk was to meet with Mrs Pearson to arrange to take over the website.

8. Finance

Income & Expenditure

The Parish Clerk circulated schedules of Income and Expenditure relating to November 2018 and the schedules were accepted by members.

9. Planning

The Clerk had previously circulated a schedule relating to all current planning applications which is appended to these minutes.

Concern was raised with regards to the works taking place at the Block 2, Grange Meadow, Ingon Lane and The Clerk was to submit a response to the Planning Authority.

11. Neighbourhood Plan

Councillor C Kimberley reported that the Neighbourhood Plan had now been delivered to each business in the village.

The Neighbourhood Plan website had now been decommissioned and all documents were available on the District Council's website.

12. Village Hall

Councillor P Blanchard updated members on the refurbishment project reported that an electrical cable needed to be relocated by Western Power and it was expected to cost approximately £1073.

An Asbestos survey had been carried out at the Village Hall and a full report had been sent to the Village Hall Management Committee and the Clerk.

The floor tiles in the toilets and the adjoining corridor returned a positive result for asbestos content, this is bonded form and a low grade of ACM. WKA who carried out the survey were to address the issues.

13. Pavilion

An Asbestos survey had also been carried out at the Pavilion and a full report had been sent to the Clerk.

It was noted that the Pavilion has asbestos lined fibreboard all around the inside of the exterior wall and roof. This has been over clad with plasterboard so. For the most part is well concealed, above the false ceiling however it is all quite visible, and some lightly damaged areas do require some encapsulation. The roof of the pavilion also returned a positive for Asbestos content. This requires maintenance only when is necessary and as it is of low asbestos content it is of no real concern.

14. Observations from Parish Councillors

Councillor P Smith asked if the Clerk for a map showing grit bins in the village to ensure that the list was up to date, and he offered to check that there were adequate supplies of salt.

Councillor C Kimberley gave an overview of the proposed lighting at Appleton House and she was to draft a suitable response for the Clerk to forward to the Planning Authority.

The meeting closed at 8.50pm.
